PRELIMINARY

1. EXCLUSION OF TABLE A

The regulations contained in Table A in the Schedule to The Companies (Tables A to F) Regulations 1985 (and any amendment, re-enactment or substitution thereof from time to time including that made by the Companies (Tables A to F) (Amendment) Regulations 2007 and the Companies (Tables A to F) (Amendment No. 2) Regulations 2007) or any articles set out in any statute or in any statutory instrument or other subordinate legislation made under any statute, shall not apply to the Company except insofar as they are repeated or contained in these Articles.

2. LIABILITY OF MEMBERS

The liability of the members is limited to the amount, if any, unpaid on the shares held by them.

3. DEFINITIONS

In these Articles unless the context otherwise requires:

"the 2006 Act" means the Companies Act 2006 to the extent in force and as amended from time to time;

"address" has the meaning given to it in section 1148 of the 2006 Act;

"AIFM Rules" means The Alternative Investment Fund Managers Directive (2011/61/EU) and all applicable rules and regulations implementing the that Directive;

"these Articles" means these articles of association as altered from time to time and the expression "this Article" shall be construed accordingly;

"the Auditors" means the auditors from time to time of the Company or, in the case of joint auditors, any one of them;

"the Board" means the board of directors from time to time of the Company or the directors present at a meeting of the directors at which a quorum is present;

"certificated share" means a share which is not an uncertificated share;

"clear days" means in relation to the period of a notice, that period excluding the day when the notice is served or deemed to be served and the day for which it is given or on which it is to take effect;

"the Company" means Value and Indexed Property Income Trust PLC;

"electronic form" when describing a document or information means sent or supplied in electronic form in accordance with section 1168 of the 2006 Act;

"electronic means" when describing a document or information means sent or supplied by electronic means in accordance with section 1168 of the 2006 Act;

"electronic signature" means anything in electronic form, which the Board requires to be incorporated into, or otherwise associated with, a communication in electronic form for the purpose of establishing the authenticity or integrity of the communication;

"FATCA" means:

- (a) sections 1471 to 1474 of the US Internal Revenue Code of 1986 or any associated regulations or other official guidance;
- (b) any treaty, law, regulation or other official guidance enacted in any other jurisdiction, or relating to an intergovernmental agreement between the US and any other jurisdiction, which (in either case) facilitates the implementation of paragraph (a) above; or
- (c) any agreement pursuant to the implementation of paragraphs (a) or (b) above with the US Internal Revenue Service, the US government or any governmental or taxation authority in any other jurisdiction;

"the holder" in relation to any shares means the member whose name is entered in the Register as the holder of those shares;

"issuer-instruction" means a properly authenticated dematerialised instruction (sent or received by means of a relevant system) attributable to a body corporate which has issued a share or shares belonging to a participating class;

"the London Stock Exchange" means London Stock Exchange plc;

"the Office" means the registered office from time to time of the Company or in the case of sending or supplying documents or information by electronic means, the address specified by the Board for the purpose of receiving documents or information by electronic means;

"Operator" means a person approved as operator of a relevant system under the Uncertificated Securities Regulations;

"Operator-instruction" means a properly authenticated dematerialised instruction (sent or received by means of a relevant system) attributable to an Operator;

"paid up" means paid up or credited as paid up;

"participating class" means a class of shares title to which may be transferred by means of a relevant system;

"person entitled by transmission" means a person whose entitlement to a share in consequence of the death or bankruptcy of a member or of any other event giving rise to its transmission by operation of law has been noted in the Register;

"properly authenticated dematerialised instruction" has the meaning attributed to it in the Uncertificated Securities Regulations;

"the Register" means the register of members of the Company;

"relevant system" has the meaning attributed to it in regulation 3(1) of the Uncertificated Securities Regulations;

"seal" means any common or official seal that the Company may be permitted to have under the Statutes;

"the secretary" means the secretary, or (if there are joint secretaries) any one of the joint secretaries, of the Company and includes an assistant or deputy secretary and any person appointed by the Board to perform any of the duties of the secretary;

"sponsoring system-participant" means in relation to a relevant system a person who is permitted by an Operator to send properly authenticated dematerialised instructions attributable to another person and to receive properly authenticated instructions on another person's behalf;

"Statutes" means the 2006 Act and every statute (including any orders, regulations or other subordinate legislation made under it) from time to time in force concerning companies in so far as it applies to the Company;

"UKLA" means the UK Listing Authority, a division of the Financial Conduct Authority;

"Uncertificated Securities Regulations" means the Uncertificated Securities Regulations 2001 (SI 2001 No. 2001/3755) as amended from time to time and any provisions of or under the Statutes which supplement or replace such Regulations;

"uncertificated share" means a share of a class which is for the time being a participating class title to which is recorded on the Register as being held in uncertificated form; and

"United Kingdom" means Great Britain and Northern Ireland.

- 3.1. In the reference to "**sponsoring system-participant**" above, the word "person" shall include any body corporate.
- 3.2. The expression "**debenture**" shall include "**debenture stock**".
- 3.3. The words "**subsidiary**" and "**holding company**" shall be construed in accordance with ~~sections~~ sections 1159 and 1160 of the 2006 Act and "**subsidiary**" shall be construed to include "**subsidiary undertaking**" as that term is defined in section 1162 of the 2006 Act.
- 3.4. Words importing the singular number only shall be deemed to include the plural, and *vice versa*.
- 3.5. Words importing the masculine gender only shall be deemed to include the feminine and neuter genders and *vice versa*.
- 3.6. Words importing individuals shall be deemed to include bodies corporate and unincorporated bodies or associations.
- 3.7. Expressions referring to "in writing" shall be construed as including references to any method of representing or reproducing words in a legible form other than in electronic form unless specifically provided for in a particular Article or where permitted by the Board in its absolute discretion.
- 3.8. References to a document being "executed" shall be construed as including references to it being executed under hand or under seal or by any other method, as permitted by the Board in its absolute discretion, except by means of an electronic signature.
- 3.9. References to a document being "signed" or to "signature" include references to it being executed under hand or under seal or by any other method, as permitted by the Board in its absolute discretion, and in the case of a communication in electronic form, are to it being an electronic signature (subject to such terms and conditions as the Board may from time to time determine).
- 3.10. Headings are for convenience of reference only and shall not affect the construction or interpretation hereof.
- 3.11. Unless otherwise stated, any reference herein to the provisions of any statute shall extend to and include any amendment or re-enactment of or substitution for the same effected by any subsequent statute provided that no modification or re-enactment after the date of adoption of these Articles of any statutory provision, instrument, regulation or order in force at that date shall be construed as imposing on any person any greater obligation than would have been the case if the statutory provision, instrument, regulation or order in force at the date of adoption of these Articles continued to apply.
- 3.12. Subject as aforesaid, and unless the context otherwise requires, words and expressions defined in the 2006 Act or the Uncertificated Securities Regulations shall bear the same meanings in these Articles.

4. FORM OF RESOLUTION

- 4.1. Subject to the Statutes, where for any purpose an ordinary resolution of the Company is required, a special resolution shall also be effective.
- 4.2. Notwithstanding the provisions of the 2006 Act relating to members' written resolutions, a resolution in writing executed by or on behalf of each member who would have been entitled to vote upon it if it had been proposed at a general meeting at which he was present shall, in accordance with the principle established in *Re Duomatic Limited* [1969] 2 Ch 265, be as effectual as if it had been passed at a general meeting properly convened and held and may consist of several instruments in the like form each executed by or on behalf of one or more of the members.

5. CHANGE OF NAME

With effect from (and including) 1 October 2009, the name of the Company may be changed be a resolution of the Board.

6.0. ~~7. REDEEMABLE SHARES~~

Subject to the provisions of the Statutes and to any rights previously conferred on the holders of any other shares, any share may be issued which is to be redeemed, or is liable to be redeemed at the option of the Company or the holder and the Board is entitled to determine the terms, conditions and manner of redemption of any such shares.

~~Subject to the provisions of the Statutes and to any requirements imposed by the UKLA in respect of securities admitted to listing, shares to be purchased rateably or in any other particular manner as between the holders of shares of the same class or as between them and the holders of shares of any other class or in accordance with the rights as to dividends or capital conferred by any class of shares.~~

7.0. ~~9.~~ WARRANTS TO SUBSCRIBE FOR SHARES

The Company may, subject to the provisions of the Statutes and of these Articles, issue warrants to subscribe for shares in the Company. Such warrants shall be issued upon such terms and subject to such conditions as may be resolved upon by the Board including, without prejudice to the foregoing generality, terms and conditions which provide that, on a winding up of the Company, a holder of warrants may be entitled to receive out of the assets of the Company available in the liquidation *pari passu* with the holders of shares of the same class as the shares in respect of which the subscription rights conferred by the warrants can be exercised such a sum as he would have received had he exercised the subscription rights conferred by his warrants prior to the winding up but under deduction of the price (if any) payable on exercise of such subscription rights.

Subject to the provisions of these presents and of the Statutes, the bearer of a warrant shall be deemed to be a member of the Company, and shall be entitled to the same privileges and advantages as he would have had if his name had been included in the Register as the holder of the shares specified in such warrant.

No person shall, as the bearer of a warrant, be entitled:

- (a) to assign a requisition for calling a meeting, or to give notice of intention to submit a resolution to a meeting; or

interest in the Company includes, without limitation, an interest in a Distribution made or to be made by the Company;

Person includes a body of persons, corporate or unincorporated, wherever domiciled;

REIT means a company qualifying for UK tax purposes as a real estate investment trust in accordance with Part 12 of The Corporation tax Act 2010;

Relevant Registered Shareholder means a shareholder who holds all or some of the shares in the Company that comprise a Holder of Excessive Rights Shareholding (whether or not a Holder of Excessive Rights);

Reporting Obligation means any obligation from time to time of the Company to provide information or reports to HMRC as a result of or in connection with the Company's status as a REIT,

Holder of Excessive Rights means an overseas company who is beneficially entitled (directly or indirectly) to 10 per cent. or more of the Ordinary Shares or dividends of the Company or controls (directly or indirectly) 10 per cent. or more of the voting rights of the Company and such overseas company does not receive relief for UK tax suffered on PIDs as a result of a specific REIT clause under the terms of a double tax agreement;

Holder of Excessive Rights Shareholding means the Ordinary Shares in respect of which a Holder of Excessive Rights is entitled to dividends (directly or indirectly) and/or to which a Holder of Excessive Rights is beneficially entitled (directly or indirectly) and/or votes attached to which are controlled (directly or indirectly) by the Holder of Excessive Rights;

In the event of conflict with defined terms elsewhere in these Articles, the definitions in this Article 160.3 shall apply.

160.4.0. Where under Articles 160.1 to 160.31 inclusive any certificate or declaration may be or is required to be provided by any Person (including, without limitation, a Distribution Transfer Certificate), such certificate or declaration may be required by the board (without limitation)

- () to be addressed to the Company, the board or such other Persons as the board may determine (including HMRC);
- () to include such information as the board considers is required for the Company to comply with any Reporting Obligation;
- () to contain such legally binding representations and obligations as the board may determine;
- () to include an undertaking to notify the Company if the information in the certificate or declaration becomes incorrect, including prior to such change;
- () to be copied or provided to such Persons as the board may determine (including HMRC), and

() his becoming a Relevant Registered Shareholder or being a Relevant Registered Shareholder on the date Articles 160.1 to 160.31 inclusive come into effect (together with such details of the relevant Holder of Excessive Rights and such other information, certificates or declarations as the board may require from time to time); and

() any change to the particulars contained in any such notice, including on the relevant Person ceasing to be a Holder of Excessive Rights or a Relevant Registered Shareholder.

Any such notice shall be delivered by the end of the second business day after the day on which the Person becomes a Holder of Excessive Rights or a Relevant Registered Shareholder (or the date Articles 160.1 to 160.31 inclusive come into effect, as the case may be) or the change in relevant particulars or within such shorter or longer period as the board may specify from time to time any Holder of Excessive Rights who fully discharged all obligations to give notice under any predecessor version of this Article 160.6 shall not be required to serve notice on the Company under this Article 160.6 solely by virtue of this version of Article 160.6 coming into effect.

No Person may be nominated under Articles 160.1 to 160.31 inclusive who is or would, on becoming a beneficiary in accordance with the nomination, become a Holder of Excessive Rights If the Holder of Excessive Rights making the nomination is not by virtue of Article 160.15 the trustee of the trust, the nomination shall not take effect until it is delivered to the Person who is the trustee.

160.17.0.Any income arising from a Distribution which is held on trust under Article 160.15 shall until the earlier of (i) the making of a valid nomination under Article 160.16 and (ii) the expiry of the period of 12 years from the date when the Distribution is paid be accumulated as an accretion to the Distribution. Income shall be treated as arising when payable, so that no apportionment shall take place.

160.18.0.No Person who by virtue of Article 160.15 holds a Distribution on trust shall be under any obligation to invest the Distribution or to deposit it in an interest-bearing account.

160.19.0.No Person who by virtue of Article 160.15 holds a Distribution on trust shall be liable for any breach of trust unless due to his own wilful fraud or wrongdoing or, in the case of an incorporated Person, the fraud or wilful wrongdoing of its directors, officers or employees.

160.20.0.If at any time, the board believes that:

- () in respect of any Distribution declared or announced, the condition set out in Article 160.9 is satisfied in respect of any shares in the Company in relation to that Distribution;
- () a notice given by the board pursuant to Article 160.7 in relation to any shares in the Company has not been complied with to the satisfaction of the board within the period specified in such notice; or
- () any information, certificate or declaration provided by a Person in relation to any shares in the Company for the purposes of Articles 160.1 to 160.31 inclusive were materially inaccurate or misleading.

the board may give notice in writing (a Disposal Notice) to any Persons they believe are Relevant Registered Shareholders in respect of the relevant shares requiring such Relevant Registered Shareholders within twenty-one (21) days of the date of service of the Disposal Notice (or such longer or shorter time as the board considers to be appropriate in the circumstances) to dispose of such number of shares the board may in such Disposal Notice specify or take such other steps as will cause the condition set out in Article 160.9 to no longer be satisfied. The board may, if it thinks fit, withdraw a Disposal Notice

160.21.0.If:

- () the requirements of a Disposal Notice are not complied with to the satisfaction of the board within the period specified in the relevant notice and the relevant Disposal Notice is not withdrawn; or
- () a Distribution is paid on a Holder of Excessive Rights Shareholding and an Excess Charge becomes payable.

the board may arrange for the Company to sell all or some of the shares to which the Disposal Notice relates or, as the case may be, that form part of the Holder of Excessive Rights Shareholding concerned. For this purpose, the board may make such arrangements as it deems appropriate. In particular, without limitation, they may authorise any officer or employee of the Company to execute any transfer or other document on behalf of the holder or holders of any relevant share and, in the case of an uncertificated share, may make such arrangements as they think fit on behalf of the relevant holder or holders to transfer title to the relevant share through a relevant system.

160.22.0.Any sale pursuant to Article 160.21 above shall be at the price which the board considers is the best price reasonably obtainable and the board shall not be liable to the holder or holders

of the relevant share for any alleged deficiency in the amount of the sale proceeds or any other matter relating to the sale.

160.23.0. The net proceeds of the sale of any share under Article 160.21 (less any amount to be retained pursuant to Article 160.14 and the expenses of sale) shall be paid over by the Company to the former holder or holders of the relevant share upon surrender of any certificate or other evidence of title relating to it, without interest. The receipt of the Company shall be a good discharge for the purchase money.

160.24.0. The title of any transferee of shares shall not be affected by an irregularity or invalidity of any actions purportedly taken pursuant to Articles 160.1 to 160.31 inclusive.

160.25.0. The board shall be entitled to presume without enquiry, unless any director has reason to believe otherwise, that a Person is not a Holder of Excessive Rights or a Relevant Registered Shareholder.

160.26.0. The board shall not be required to give any reasons for any decision or determination (including any decision or determination not to take action in respect of a particular Person) pursuant to Articles 160.1 to 160.31 inclusive and any such determination or decision shall be final and binding on all Persons unless and until it is revoked or changed by the board. Any disposal or transfer made or other thing done by or on behalf of the board or any director pursuant to Articles 160.1 to 160.31 inclusive shall be binding on all Persons and shall not be open to challenge on any ground whatsoever.

160.27.0. Without limiting their liability to the Company, the board shall be under no liability to any other Person, and the Company shall be under no liability to any shareholder or any other Person, for identifying or failing to identify any Person as a Holder of Excessive Rights or a Relevant Registered Shareholder.

160.28.0. The board shall not be obliged to serve any notice required under Articles 160.1 to 160.31 inclusive upon any Person if they do not know either his identity or his address. The absence of service of such a notice in such circumstances or any accidental error or failure to give any notice to any Person upon whom notice is required to be served under Articles 160.1 to 160.31 inclusive shall not prevent the implementation of or invalidate any procedure under those Articles.

160.29.0. The provisions of Articles 150 to 155 inclusive shall apply to the service upon any Person of any notice required by Articles 160.1 to 160.31 inclusive. Any notice required by Articles 160.1 to 160.31 inclusive to be served upon a Person who is not, a shareholder or upon a Person who is a shareholder but whose address is not within an EEA State, shall be deemed validly served if such notice is sent through the post in a pre-paid cover addressed to that Person or shareholder at the address if any at which the board believes him to be resident or carrying on business or, in the case of a holder of depository receipts or similar securities, to the address, if any, in the register of holders of the relevant securities. Service shall, in such a case be deemed to be effected on the day of posting and it shall be sufficient proof of service if that notice was properly addressed, stamped and posted.

160.30.0. Any notice required or permitted to be given, pursuant to Articles 160.1 to 160.31 inclusive may relate to more than one share and shall specify the share or shares to which it relates.

160.31.0. The board may require from time to time any Person who is or claims to be a Person to whom a Distribution may be paid without deduction of tax under Regulation 7 of the Real Estate Investment Trusts (Assessment and Recovery of Tax) Regulations 2006 to provide such certificates or declarations as they may require from time to time.
